

AKLEASE ENVIRONMENTAL AND SOCIAL RISK MANAGEMENT POLICY

Aklease, one of the leading companies in leasing sector, has considered 'Environment and Social Responsibility' as a significant factor in full range of its activities. In this sense, Aklease has showed utmost care in financing environmentally reliable and sustainable projects in its activities.

Aklease performs its environmental and social risk management activities in line with the Aklease Environmental and Social Risk Management Policy. The following principles are set out under this policy:

- 1. Aklease is sensitive in ensuring that the United Nations Global Compact of Principles (UN Global Impact) are also applied by its customers.
- Aklease not knowingly provides financial leasing services to companies and corporations engaged
 in activities that are given in "Environmental and Social Exclusion List" attached to this policy and
 that are prohibited / restricted by legal regulations and international agreements to which our
 country is a party without any financial, technical, environmental and social impact assessment.
- 3. Environmental and social risk criteria are taken into consideration in financial leasing transactions and projects with serious negative impacts on the environment and society are not supported.
- 4. In leasing transactions over US \$ 5 million, which are not included in the "Environmental and Social Exclusion List"; the customer requesting leasing services and the related transaction is subject to the Environmental and Social Risk Assessment Model established within the scope of the Environmental and Social Management System.
- 5. The Environmental and Social Management System is reviewed with the objective of continuously improving the annual performance and regularly shared with the senior management.
- 6. Projects that contribute to sustainable development in Turkey are priority projects to be financed.
- 7. Projects that will contribute to sustainable development in Turkey has a priority.
- 8. The company ensures compliance with national laws and regulations on environmental and social issues, labor protection and health &safety protection
- 9. Aklease aims to minimize its environmental impact by controlling the its operations. The Company is engaged in energy and paper saving, paper and waste reduction and waste recycling.
- 10. Aklease supports and respects the protection of human rights and complies with national standards for illegal labor, child abuse or forced labor.



- 11. Aklease oversees issues related to business continuity, occupational safety and health, emergency preparedness and response. The company also supports the development of systems that contribute to the development of occupational health and safety and the development of employee competence.
- 12. Aklease strives in minimizing at best the detrimental effects that any funded project might have on the underprivileged/fragile groups of society with extra emphasis on gender equality.

Environmental and Social Policy covers all Aklease activities. The personnel duties and responsibilities required in each process have been defined during the decision-making process.

General Manager is responsible for the follow-up, update and execution of the policy lies with the, and Board of Directors is responsible for its approval and cancellation. The policy is part of the Aklease Environmental and Social Management System.

This policy was adopted by the Board of Directors on 01.06.2021 and entered into force.
